NEWS FROM THE AGM

The Federation's 2018 Annual General Meeting was held in Ilkley on 3rd November, when our hosts were the Wharfedale Recorded Music Society.

In his Chairman's address, Allan Child referred to changes in the Federation. He recorded thanks to Jim Bostwick on his 'retirement' as Secretary and to Paul Astell who has stood down as Editor of the *Bulletin*. But whilst we have a successor to Jim as Secretary, no one has yet been appointed to take on the editorship of the *Bulletin*.

With Jim and Paul standing down there were two vacancies on the committee. The remaining current members had all been re-nominated and the additional nomination of Simon Rawlings of the Weston-super-Mare Music Appreciation Society means that the committee still has its full

quota of elected members although the position of *Bulletin* editor, which is a committee appointment, remains vacant.

FUTURE OF THE *BULLETIN*

As recorded above, Paul Astell has relinquished editorship of the *Bulletin* but it has not been possible to find a successor to Paul. The Autumn 2018 issue, therefore, was the final issue, in that format at least, for the foreseeable future, although many societies in their responses to the recent questionnaire indicated that they would like to see the *Bulletin* continue in that format.

The future of the *Bulletin* was considered at the November committee meeting and it was felt that with falling numbers of affiliated societies, and therefore lower readership it was difficult to justify continuing to produce the *Bulletin* in the recent format and to attract sufficient advertising to offset against production costs.

It is clearly necessary, though, to maintain regular contact with societies. It is likely that a replacement for the *Bulletin* will emerge in the form of a newsletter, though rather more substantial in format than those recently issued (including this one). There would be space for reports on society and regional activities as well as news from the FRMS.

The practical aspects of producing such a publication are still being considered by the Committee and offers of assistance or expressions of interest are welcome. Please contact the Federation Secretary in the first instance.

MUSIC WEEKENDS

For the Yorkshire and Northwest Region's Music Weekend in Ilkley it is once again very much business as usual – and this year it is a little later so the organisers hope this will lessen the chances of encountering the wintry conditions of last year. The event runs from Friday 5th to Monday 8th April and there are presenters both from within the FRMS and from the wider musical world – including some who have not previously spoken at a Federation event.
